

**Brazos County Regional Mobility Authority**

**Board Meeting Minutes**

August 8, 2025

---

• **Call to Order**

A board meeting of the Brazos County Regional Mobility Authority (BCRMA) was held in the Brazos County Commissioner's Courtroom, 200 South Texas Avenue, Bryan, Texas, beginning at 10:01 a.m. on Friday, August 8, 2025, with the following Board members present: Karl Mooney, Chair, Presiding; Dennis Christiansen, Vice Chair; Veronica Morgan, Member; and Alan Munger, Member. The attached sheet contains the names of additional citizens/officials that were in attendance.

• **Public Comments**

Mr. Roger Lasater of Bryan, Texas, addressed the RMA Board regarding his difficulty with following RMA happenings on the website. The site is in need of more information so that the Board can show it is being transparent with local residents.

• **Approval of Minutes from the November 1, 2024, RMA Board Meeting**

Minutes from the November 1, 2024, Brazos County Regional Mobility Authority Board Meeting were considered for adoption. **A motion to approve the minutes was made by Dr. Christiansen. The motion was seconded by Mr. Munger. The motion passed by a unanimous vote.**

• **Review and Adopt Fiscal and Personnel Management Agreement between the RMA and Brazos County**

The Fiscal and Personnel Management Agreement was drafted by Brazos County General Counsel. The purpose of the agreement is to allow Brazos County to serve as the fiscal and personnel agent for the organization. This agreement specifies the roles and responsibilities of both parties and allows the RMA to be considered a county subdivision for the purpose of benefits and other finance related cost savings.

**A motion was made by Mr. Munger to approve the Interlocal Agreement with Brazos County. The motion was seconded by Dr. Christiansen. The motion passed by a unanimous vote.**

- **Adoption of FY 2026 Operating Budget**

The Board must budget funds in FY 2026 for the required external audit of FY 2025 funds and procedures. The cost of the audit is expected to be approximately \$4,000; however, additional funds are being requested to cover any overage.

**A motion was made by Mr. Munger to adopt the FY 2026 Operating Budget of \$5,000. The motion was seconded by Dr. Christiansen. The motion passed by a unanimous vote.**

- **Discussion of Current County-Wide Transportation Projects and Needs**

Chairmen Mooney commented that we have significant transportation investment about to be made in Brazos County including over \$800,000,000 for State Highway Six and over \$100,000,000 for the Bush/Wellborn interchange. It was suggested that the Board also stay involved with the planning for Interstate 14 and I-214. Finally the Board discussed rail service in Brazos County, the needs of Union Pacific and the potential of Amtrak service.

- **Discussion of a Brazos County/Brazos Valley Transportation Survey**

Currently there is no funding for a transportation survey. If this is an item the RMA Board would like to pursue, they will need to seek out funds to cover the expense. It was also discussed that a transportation survey should be led by the MPO.

- **Discussion of Passenger Airline Service**

Chairmen Mooney discussed the need for an additional commercial carrier for air service in Bryan/College Station. It was determined that a discussion with airport management should take with the RMA Chair.

- **Board Member Reports/Comments**

Dr. Christiansen stated that with the significant investment TxDOT is making on State Highway 6 and the Bush/Wellborn interchange, we should not expect additional large investments in roadway construction for at least 15-20 years. There were no additional reports/comments.

- **Chairman's Report**

Chairmen Mooney requested that anyone wishing to contact the RMA should reach out to him as there is not currently any staff. He asked Ms. Lyon to see how we can make the website easier for citizens to use. Mr. Mooney added that since this is his first meeting as Chair, he will work to keep transportation issues at the forefront of all RMA discussions. Mr. Mooney said that he would begin to look at what reports needed to be completed and that he would bring any time sensitive issues to the Board at their next quarterly meeting.

- **Adjourn**


